13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The Board of Supervisors hereby adopts and implements the 2018-2021
15 Memorandum of Understanding (“MOU”) between the City and County of San Francisco and
16 the San Francisco Fire Fighters Union, Local 798, Unit 2, to be effective July 1, 2018 through
17 June 30, 2021.

18 The MOU so implemented is on file with the Clerk of the Board of Supervisors in Board
19 File No. 180503.

20 Section 2. The Board of Supervisors hereby authorizes the Department of Human
21 Resources to make non-substantive ministerial or administrative corrections to the MOU.

23 Section 3. Effective Date. This ordinance shall become effective upon enactment.
24 Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance

2 Supervisors overrides the Mayor's veto of the ordinance.


