11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Renee Owens v. Friendship Village,
13 Inc., et al., San Francisco Superior Court, Case No. CC-23-604879 by the payment of up to
14 \$650,000 and judgment to be entered only against the City and County of San Francisco in
15 that amount. The lawsuit involves alleged wrongful death on a City sidewalk.

16 Section 2. The above-named action was filed in San Francisco Superior Court on
17 March 1, 2024, and the following parties were named in the lawsuit: plaintiff Renee Owens,
18 defendants Friendship Village, Inc. and City and County of San Francisco.

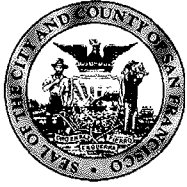
