16 Veronica Fulton, Aidan Gauper and Cory Maryott; Defendant City and County of San
17 Francisco. This is a partial settlement of the case involving Plaintiff Ralph Bower only.

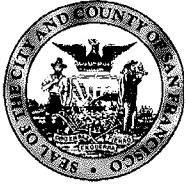
