13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The Board of Supervisors hereby adopts and implements the Memorandum  
15 of Understanding ("MOU") between the City and County of San Francisco and the Teamsters,  
16 Local 856: Supervising Registered Nurses, to be effective July 1, 2019 through  
17 June 30, 2022.

18 The MOU so implemented is on file with the Clerk of the Board of Supervisors in Board  
19 File No. 190640.


20 Section 2. The Board of Supervisors hereby authorizes the Department of Human  
21 Resources to make non-substantive ministerial or administrative corrections to the MOU.

22 Section 3. Effective Date. This ordinance shall become effective upon enactment.  
23 Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance
