14	Section 1. Declaration of Emergency Pursuant to Charter Section 2.107.
15	(a) Section 2.107 of the Charter authorizes passage of an emergency ordinance in
16	cases of public emergency affecting life, health, or property, or for the uninterrupted operation
17	of any City or County department or office required to comply with time limitations established
18	by law. An emergency ordinance enacted under Charter Section 2.107 automatically
19	terminates on the 61st day after passage, but may be reenacted upon the same terms and
20	conditions applicable to its initial enactment.
21	(b) Pursuant to Charter Section 2.107, the City enacted Ordinance No. 104-20, the
22	"Back to Work" emergency ordinance, which temporarily requires certain employers operating
23	in San Francisco to offer reemployment to eligible employees laid off as a result of the
24	COVID-19 public health emergency.

1	(c) The Board of Supervisors hereby finds that the findings declared in Sections 2 and

2	3 of Ordinance No. 104-20 remain valid and compelling, and declares further that an actual
3	emergency continues to exist that requires the reenactment of the Back to Work emergency
4	ordinance to mitigate the economics effects of layoffs caused by the public health emergency
5	COVID-19 continues to present an extremely dangerous public health risk to the community,
6	and the adverse economic impact on workers and their families remains severe,
7	notwithstanding gradual efforts to reopen sectors of the economy. Further, many employees
8	continue to experience family caregiving challenges due to school and care facility closures,
9	challenges securing caregiving assistance, and the planned continuation of distance learning
10	during the upcoming academic year.

Section 2. Reenactment of Emergency Ordinance.

Consistent with Charter Section 2.107, this emergency ordinance reenacts for an additional 60 days the emergency ordinance temporarily requiring certain employers operating in San Francisco to offer reemployment to eligible employees laid off as a result of the COVID-19 public health emergency (Ordinance No. 104-20).

Section 3. Effective Date; Expiration.

 (a) If enacted prior to the expiration of Ordinance No. 104-20, this reenacted emergency ordinance shall become effective immediately upon the date of expiration of Ordinance No. 104-20, and shall itself expire on the 61st day following its effective date

unless reenacted as provided by Charter Section 2.107.

(b) If enacted after the expiration of Ordinance No. 104-20, this reenacted emergency ordinance shall become effective immediately upon enactment, and shall expire on the 61st day following its effective date unless reenacted as provided by Charter Section 2.107.
