10 Be it ordained by the People of the City and County of San Francisco:


11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby

14 Francisco Superior Court, Case No. CGC-17-562069 by the payment of \$125,000. The
15 lawsuit involves alleged medical negligence.

17 October 23, 2017, and the following parties were named in the lawsuit: Plaintiffs: Emmett
18 Waldrip, an incompetent, by Dixie Waldrip, his conservator of the estate; Defendant: City and




