

14 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-15-543559 by
15 the payment of \$156,250 and co-defendant Regents of the University of California to pay
16 \$156,250. The lawsuit involves alleged medical negligence.


17 Section 2. The above-named action was filed in San Francisco Superior Court on

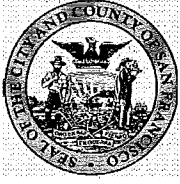
