12 Be it ordained by the People of the City and County of San Francisco:


13 Section 1. The Board of Supervisors hereby adopts the rate determined by the  
14 Controller, pursuant to Business and Tax Regulations Code Article 12B-1, Section 1032, as  
15 the percentage ceiling that a taxpayer may designate for deposit in the Neighborhood  
16 Beautification and Graffiti Clean-up Fund. Said determination is on file with the Clerk of the  
17 Board of Supervisors in File No. 170676, and is incorporated herein by reference. For the  
18 2017 tax year, the designation ceiling shall be 3.4% of a taxpayer's payroll expense tax and  
19 gross receipts tax liability for the year.

20 The Treasurer and Tax Collector shall post the designation ceiling to the website of the  
21 Treasurer and Tax Collector.

22 Section 2. Effective Date. This ordinance shall become effective 30 days after  
23 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the

1 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
2 of Supervisors overrides the Mayor's veto of the ordinance.
