9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
10 authorizes the City Attorney to settle the action entitled Stuart Kohler v. City and County of  
11 San Francisco, et al., United States District Court, Case No. 16-CV-6502 by the payment of  
12 \$75,000. The lawsuit involves alleged civil rights violations.

13 Section 2. The above-named action was filed in United States District Court on  
14 November 8, 2016, and the following parties were named in the lawsuit: Plaintiff Stuart Kohler  
15 and Defendants Lt. Christopher Krol, Sergeant Paul Del Rosario, Senior Deputy Donald
