3 **Ordinance authorizing partial settlement of the lawsuit filed by Carlos Gross against**  
4 **the City and County of San Francisco for \$210,000; the lawsuit was filed on**  
5 **August 20, 2015, in San Francisco Superior Court, Case No. CGC-15-547492; entitled**  
6 **David Alfaro, et al. v. City and County of San Francisco; the lawsuit involves inverse**  
7 **condemnation arising out of flooding damage during major rainstorms in December**  
8 **of 2014; this settlement relates only to the diminution of real property value claims of**  
9 **plaintiff Carlos Gross, and does not include claims for property loss or for attorney's**  
10 **fees, costs and interest.**

11  
12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
14 authorizes the City Attorney to settle in part, and only as to plaintiff Carlos Gross, the action  
15 entitled David Alfaro, et al. v. City and County of San Francisco, San Francisco Superior  
16 Court, Case No. CGC-15-547492 by the payment of \$210,000 to plaintiff Carlos Gross. The  
17 lawsuit involves inverse condemnation arising out of flooding damage during major rainstorms  
18 in December of 2014.

19 Section 2. The above-named action was filed in San Francisco Superior Court on  
20 August 20, 2015. This is an action brought by owners or occupants of several dozen  
21 properties located in San Francisco against defendant City and County of San Francisco.

22 Section 3. This is a partial settlement of the action. It resolves the diminution of real  
23 property value claims of plaintiff Carlos Gross. The parties have previously, separately settled  
24 the personal and real property damage claims of plaintiff Carlos Gross in this action (see  
25

1 Board Ordinance No. 109-18), and will subsequently and separately address all claims for  
2 statutory attorney's fees relating to this action.
