13 No. 22-cv-04600 WHO by the payment of \$75,000. The lawsuit involves alleged civil rights
14 violations.

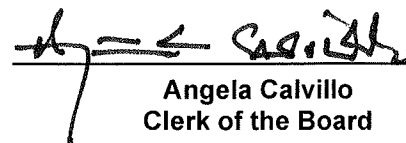
