4 **and County of San Francisco for \$155,000; the lawsuit was filed on April 10, 2014, in**  
5 **San Francisco Superior Court, Case No. CGC-14-538566; entitled Karen Caldwell v. City**  
6 **and County of San Francisco, et al.; the lawsuit involves alleged property damage**  
7 **arising from the break of the Public Utilities Commission's water transmission pipeline**  
8 **on 15th Avenue between West Portal Avenue and Wawona Street in San Francisco; and**  
9 **appropriating \$155,000 from the Water Enterprise fund balance for such purpose.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
13 authorizes the City Attorney to settle the action entitled Karen Caldwell v. City and County of  
14 San Francisco, et al., San Francisco Superior Court, Case No. CGC-14-538566 by the  
15 payment of \$155,000. The lawsuit involves alleged property damage from the break of the  
16 SFPUC's water transmission pipeline on 15th Avenue between West Portal Avenue and  
17 Wawona Street in San Francisco.


18 Section 2. The above-named action was filed in San Francisco Superior Court on April





