4 **actions and impose a statute of repose with respect to Propositions C and G, adopted**  
5 **by San Francisco voters on June 5, 2018.**

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The Business and Tax Regulations Code is hereby amended by adding  
15 Section 6.15-4 to Article 6, to read as follows:

16 **SEC. 6.15-4. VALIDATION ACTIONS; STATUTE OF REPOSE.**

17 *(a) Chapter 9 (commencing with Section 860) of Title 10 of Part 2 of the California Code of*  
18 *Civil Procedure applies to any judicial action or proceeding to validate, attack, review, set aside, void,*  
19 *or annul Propositions C and/or G, adopted by San Francisco voters on June 5, 2018.*

20 *(b) For purposes of this Section 6.15-4, Propositions C and G, adopted by San Francisco*  
21 *voters on June 5, 2018, shall be deemed to have been adopted on the effective date of this Section for*  
22 *purposes of determining the limitations period in Section 860 of the California Code of Civil*  
23 *Procedure.*

24 *(c) Any appeal from the final judgment in an action or proceeding brought under Section 6.15-*  
25 *4(a) shall be filed within 30 days after entry of the judgment.*

1 Section 2. Effective Date. This ordinance shall become effective 30 days after  
2 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
3 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
4 of Supervisors overrides the Mayor's veto of the ordinance.



