

[Planning Code; Zoning Map - Consolidating the North Beach Special Use and Neighborhood Commercial Districts and Expanding Allowable Uses and Use Size Limits in Certain Zoning Districts]

Ordinance amending the Planning Code to: 1) eliminate the North Beach Special Use District and consolidate certain controls into the North Beach Neighborhood Commercial District, expand allowable uses and increase use size limits in the North Beach Neighborhood Commercial District, 2) expand allowable uses and increase use size limits in the Polk Street Neighborhood Commercial District, 3) expand allowable uses in the Pacific Avenue Neighborhood Commercial District, 4) expand allowable uses and increase use size limits in the Nob Hill Special Use District, and 5) reduce limitations on Restaurants and Bars in the Jackson Square Special Use District; amending the Zoning Map to reflect removal of the North Beach Special Use District; affirming the Planning Department's determination under the California Environmental Quality Act; making findings of consistency with the General Plan and the eight priority policies of Planning Code, Section 101.1; and making findings of public necessity, convenience, and welfare under Planning Code, Section 302.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Environmental and Land Use Findings.

(a) The Planning Department has determined that the actions contemplated in this ordinance comply with the California Environmental Quality Act (California Public Resources

1 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
2 Supervisors in File No. 250682 and is incorporated herein by reference. The Board affirms
3 this determination.

4 (b) On September 25, 2025, the Planning Commission, in Resolution No. 21822,
5 adopted findings that the actions contemplated in this ordinance are consistent, on balance,
6 with the City's General Plan and eight priority policies of Planning Code Section 101.1. The
7 Board adopts these findings as its own. A copy of said Resolution is on file with the Clerk of
8 the Board of Supervisors in File No. 250682, and is incorporated herein by reference.

9 (c) Pursuant to Planning Code Section 302, the Board of Supervisors finds that the
10 actions contemplated in this ordinance will serve the public necessity, convenience, and
11 welfare for the reasons set forth in Planning Commission Resolution No. 21822, and adopts
12 such reasons by this reference thereto. A copy of said Resolution is on file with the Clerk of
13 the Board of Supervisors in File No. 250682, and is incorporated herein by reference.

15 Section 2. Article 1 of the Planning Code is hereby amended by revising Section 102,
16 to read as follows:

17 **SEC. 102. DEFINITIONS.**

18 For the purposes of this Code, certain words and terms used herein are defined as set
19 forth in this and the following sections. Additional definitions applicable to Signs are set forth
20 in Section 602. Additional definitions applicable to development impact fees and requirements
21 that authorize the payment of in-lieu fees are set forth in Section 401. Additional definitions
22 applicable only to Downtown Residential Districts are set forth in Section 890. ~~Additional~~
23 ~~definitions applicable only to the North Beach Neighborhood Commercial District and the North Beach~~
24 ~~Special Use District are set forth in Section 780.3.~~ Additional definitions applicable only to the
25 Bernal Heights Special Use District are set forth in Section 242. Additional definitions

1 applicable only to Article 9, Mission Bay Districts, are set forth in Section 996. All words used
2 in the present tense shall include the future. All words in the plural number shall include the
3 singular number, and all words in the singular number shall include the plural number, unless
4 the natural construction of the wording indicates otherwise. The word "shall" is mandatory
5 and not directory. Whenever any of the following terms is used it shall mean the
6 corresponding officer, department, board or commission or its successor of the City and
7 County of San Francisco, State of California, herein referred to as the City: Assessor, Board
8 of Supervisors, Planning Department, Department of Public Works, Director of Planning,
9 Planning Commission, or Zoning Administrator. In each case, the term shall be deemed to
10 include an employee of any such officer or department of the City who is lawfully authorized to
11 perform any duty or exercise any power as a representative or agent of that officer or
12 department.

13 * * * *

14 ***Restaurant, Limited.*** A Retail Sales and Service Use that serves ready-to-eat foods
15 and/or drinks to customers for consumption on or off the premises, that may or may not have
16 seating. It may include wholesaling, manufacturing, or processing of foods, goods, or
17 commodities on the premises as an Accessory Use as set forth in Sections 204.3 or 703(d),
18 803.2(d), 803.3(b)(1)(C) and 825(c)(1)(C) depending on the zoning district in which it is
19 located. It includes, but is not limited to, foods provided by sandwich shops, coffee houses,
20 pizzerias, ice cream shops, bakeries, delicatessens, and confectioneries meeting the above
21 characteristics, but is distinct from a Specialty Grocery, Restaurant, and Bar. ~~*Within the North*~~
22 ~~*Beach SUD, it is also distinct from Specialty Food Manufacturing, as defined in Section 780.3(b).*~~ It
23 shall not provide on-site beer and/or wine sales for consumption on the premises, but may sell
24 beer and/or wine for consumption off the premises with a California Alcoholic Beverage
25 Control Board License type 20 (off-sale beer and wine), if all areas devoted to the display and

sale of alcoholic beverages occupy less than 15% of the Occupied Floor Area of the establishment. Such businesses shall operate with the specified conditions in Section 202.2(a)(1).

Section 3. Article 1.2 of the Planning Code is hereby amended by revising Sections 121.2 and 145.4, to read as follows:

SEC. 121.2. NON-RESIDENTIAL USE SIZE LIMITS IN NEIGHBORHOOD COMMERCIAL AND NEIGHBORHOOD COMMERCIAL TRANSIT DISTRICTS.

(a) In order to protect and maintain a scale of development appropriate to each district, Non-Residential Use Sizes larger than the square footage stated in the table below may be permitted only as Conditional Uses, subject to the exception in Section 121.2(b). The Non-Residential Use Size shall be measured as the Gross Floor Area for each individual Non-Residential Use.

6 (a) **Purpose.** To support active, pedestrian-oriented commercial uses on important
7 commercial streets.

8 (b) **Applicability.** The requirements of this Section 145.4 apply to the following street
9 frontages.

16 186, to read as follows:

20 (a) Exemption from Termination Provisions. The following nonconforming uses in R
21 Districts shall be exempt from the termination provisions of Section 185, provided such uses
22 comply with all the conditions specified in subsection (b) below:

2 Service, Limited Financial Service, and Business or Professional Service Subdistrict set forth

20 **SEC. 238. NOB HILL SPECIAL USE DISTRICT.**

21 (a) A Hotel, as defined in Section 102 of this Code, may be permitted by the Planning
22 Commission as a eConditional #Use under Section 303 of this Code.

23 (b) In connection with any permitted pPrincipal Use or eConditional #Use located in
24 such Special Use District, incidental eCommercial #Uses may be permitted by the Planning
25 Commission as a eConditional #Use under Section 303 of this Code, if designed primarily for

1 occupants of and visitors to the use to which they are incidental, accessible to the general
2 public only from within the building, and not identified outside the building by means of any
3 sign or signs.

4 (c) A Private Community Facility as defined in Section 102 of this Code, and that is
5 not operated as a gainful (for-profit) business may be permitted by the Planning Commission
6 as a ~~e~~C~~o~~nditional ~~u~~se under Section 303 of this Code.

7 (d) Eating and Drinking uses as defined in Section 102 of this Code, ~~with the exception~~
8 ~~of Eating and Drinking uses that are also defined as Formula Retail~~ may be permitted by the
9 Planning Commission as a ~~e~~C~~o~~nditional ~~u~~se under Section 303 of this Code, ~~except that~~
10 Limited Restaurant uses as defined in Section 102 of this Code shall be permitted as Principal Uses and
11 any Eating and Drinking uses that are also defined as Formula Retail are not permitted. The
12 limitations on design, accessibility, and identification set forth in ~~S~~ubsection (b) above shall
13 not apply to such uses hereby permitted.

14 (e) Arts Activities uses as defined in Section 102 of this Code shall be principally permitted on
15 the first floor and as a Conditional Use under Section 303 of this Code on the second floor and
16 above.

17 (f) Signage for ~~p~~Principal ~~permitted~~ ~~u~~ses or for Eating and Drinking uses within the
18 Nob Hill Special Use District shall be limited as per Section 606 of this Code, with the
19 exception that projecting ~~s~~Signs in the form of sign copy on ~~e~~C~~a~~noopies and ~~a~~A~~w~~nings shall be
20 permitted for Eating and Drinking uses in lieu of ~~w~~all ~~s~~Signs unless otherwise limited as a
21 condition of approval of a ~~e~~C~~o~~nditional ~~u~~se authorization.

22 (fg) An existing Retail Professional Service, as defined in Section 102 of this Code,
23 that has operated without the benefit of a permit prior to June 17, 2025, may be principally
24 permitted and allowed to expand into another commercial space within the same structure.
25 Such use shall not be required to be incidental to a Principal or Conditionally Permitted use on

1 the site. Additionally, such use shall be exempt from the signage and public access
2 restrictions of this SUD.

3 (h) The various uses provided for in Subsections 238(a) through 238(~~ef~~) above are not
4 permitted in any portion of a building that is devoted to a Dwelling Unit or to Group Housing as
5 defined in Section 102 of this Code.

7 **SEC. 249.25. JACKSON SQUARE SPECIAL USE DISTRICT.**

8 In order to provide for the protection and enhancement of specialty retail and antique
9 store uses in the Jackson Square area, there shall be established the Jackson Square Special
10 Use District as designated on Sectional Map No. SU01 of the Zoning Map. The boundaries of
11 this Special Use District shall be coterminous with the boundaries of the Jackson Square
12 Historic District as established by Appendix B to Article 10 of this Code and further described
13 in Section 3 of that Appendix, and shall also include Lot 4 of Block 195. The following
14 provisions shall apply within the Jackson Square Special Use District:

15 (a) **Purposes.** These controls are intended to protect and enhance the unique retail
16 character of the Special Use District. All decisions of the Planning Commission and
17 Department for the establishment of ground floor use shall be guided by the following factors:

18 (1) Continuation and enhancement of existing ground floor retail uses are of
19 critical importance to the character of the District and displacement of such uses should be
20 discouraged;

21 (2) Attraction and retention of similar new retail establishments that conform
22 with the character of this District should be encouraged; and

23 (3) Uses that greatly intensify the density of employment have a negative
24 impact on the provision of neighborhood services, traffic circulation, and limited on- and off-
25 street parking.

1 (b) **Controls.**

2 (1) **General.** The provisions of the C-2 ~~use-d~~District ~~as established in~~ (Section
3 210.21) and applicable provisions of the Washington-Broadway Special Use Districts (Section
4 239), and the Chinatown Community Business District (Section 810), shall prevail except as
5 provided in ~~subsections~~ ~~paragraphs~~ (b)(2) and (b)(3) ~~of this Section 249.25 below.~~

6 (2) **Conditional Uses.**

7 (A) **Office Uses, Business Services, and Institutional Uses.** Office
8 Uses, Business Services, and Institutional Uses, as defined in Section 102 of this Code, at the
9 ground floor are subject to Conditional Use authorization pursuant to Section 303 of this
10 Code; provided, however, that building lobbies, entrances, and exits to and from the
11 basement, ground floor, or upper floors, and other reasonably-sized common areas at the
12 ground floor shall be permitted without Conditional Use authorization. In addition to the
13 findings required under Section 303(c) for Conditional Use authorization, the Commission
14 shall make the following findings:

15 (i) The use shall be necessary to preserve the historic resource
16 and no other use can be demonstrated to preserve the historic resource.

17 (ii) The use shall be compatible with, and shall enhance, the
18 unique retail character of the District.

19 (B) **Restaurants, ~~Limited Restaurants,~~ and Bars.** Restaurant uses larger
20 than 4,000 square feet, ~~Limited Restaurant,~~ and Bar uses larger than 4,000 square feet may be
21 permitted as a Conditional Use on the First Story through the procedures set forth in Section
22 303, ~~only if the Zoning Administrator first determines that the proposed new Restaurant, Limited~~
23 ~~Restaurant, or Bar would occupy a space that is currently or was last legally occupied by one of the~~
24 ~~uses described below; provided that its last use has not been discontinued or abandoned pursuant to~~
25 ~~Sections 186.1(d) or 178(d) of this Code and that the proposed new use will not enlarge the space; and~~

provided ~~further~~ that no Conditional Use authorization shall be required if the use remains the same as the prior authorized use, with no enlargement or intensification of use.;

~~(i) A Bar may occupy a space that is currently or last legally occupied by a Bar;~~

~~(ii) A Restaurant may occupy a space that is currently or was last legally occupied by a Restaurant or Bar; and~~

~~(iii) A Limited Restaurant may occupy a space that is currently or was last legally occupied by a Limited Restaurant, Restaurant, or Bar.~~

~~(iv) Except as provided herein, no other use shall be allowed to convert to a Limited Restaurant, Restaurant, or Bar.~~

~~(C) **Exception for Certain Proposed Limited Restaurant Uses.** A proposed Limited Restaurant use is Principally Permitted, shall not be required to obtain a Conditional Use authorization pursuant to subsection (b)(2)(B) above, and shall not be subject to the limitation of subsection (b)(2)(B)(iii) above if an application for a building permit necessary for the establishment of such use was filed with the City by July 19, 2018.~~

(3) **Prohibited Uses.** Adult Businesses, as defined in Section 102 of this Code, are prohibited.

Section 6. Article 3 of the Planning Code is hereby amended by revising Sections 303.2 and 304, to read as follows:

SEC. 303.2. PRIORITY PROCESSING FOR CERTAIN USES IN COMMERCIAL SPACE: EXPEDITED CONDITIONAL USE REVIEW AND APPROVAL PROCESS AND REDUCED APPLICATION FEE.

1 (c) **Eligibility for Priority Processing.** An application for a Conditional Use
2 authorization qualifies for priority processing ("eligible application") pursuant to this Section
3 303.2 if it is seeking to establish, alter, enlarge, or intensify a commercial use on the first story
4 or below, or on the second story where the commercial use would operate on both the first
5 and second stories, in the subject building and if it complies with all of the following
6 requirements:

8 ~~(9) It is not within the North Beach Neighborhood Commercial District, as described~~
9 ~~and set forth in Section 722, or the North Beach Special Use District, as described and set forth in~~
10 ~~Section 780.3.~~

12 13 **SEC. 304. PLANNED UNIT DEVELOPMENTS.**

14 In districts other than C-3, the Eastern Neighborhoods Mixed Use Districts, the DTR
15 Districts, or the North Beach ~~Special Use~~Neighborhood Commercial District, the Planning
16 Commission may authorize as Conditional Uses, in accordance with the provisions of Section
17 303, Planned Unit Developments subject to the further requirements and procedures of this
18 Section 304. After review of any proposed development, the Planning Commission may
19 authorize such development as submitted or may modify, alter, adjust or amend the plan
20 before authorization, and in authorizing it may prescribe other conditions as provided in
21 Section 303(d). The development as authorized shall be subject to all conditions so imposed
22 and shall be excepted from other provisions of this Code only to the extent specified in the
23 authorization.

1 Section 7. Article 7 of the Planning Code is hereby amended by revising Sections 703,
2 722, 723, 726, and 780.3, to read as follows:

3 **SEC. 703. NEIGHBORHOOD COMMERCIAL DISTRICT REQUIREMENTS.**

4 * * * *

5 (d) Accessory Uses. Subject to the limitations set forth below and in Sections 204.1
6 (Accessory Uses for Dwellings in All Districts), 204.4 (Dwelling Units Accessory to Other
7 Uses), and 204.5 (Parking and Loading as Accessory Uses) of this Code, Accessory Uses as
8 defined in Section 102 shall be permitted when located on the same lot. Notwithstanding the
9 foregoing, a Retail Workspace, as defined in Section 102, shall be permitted as an Accessory
10 Use in connection with any Eating and Drinking Use regardless of the floor area occupied by
11 such Accessory Use, so long as (1) the hours of operation for the accessory Retail
12 Workspace use are limited to 9 a.m. to 5 p.m. and (2) such Eating and Drinking Use is also
13 open for business to the general public on each day during which the accessory Retail
14 Workspace use is open. Any Use that does not qualify as an Accessory Use shall be
15 classified as a Principal or Conditional Use unless it qualifies as a temporary use under
16 Sections 205 through 205.4 of this Code. Parcel Delivery Service, as defined in Section 102 of
17 the Planning Code, for merchandise or products other than cannabis and cannabis products is
18 not allowed as an accessory use to any other principal use.

19 No Use will be considered accessory to a permitted Principal or Conditional Use
20 that involves or requires any of the following:

22 (3) The wholesaling, manufacturing, or processing of foods, goods, or
23 commodities on the premises of an establishment that does not also use or provide for retail
24 sale of such foods, goods, or commodities at the same location where such wholesaling,
25 manufacturing, or processing takes place, *with the following exceptions:*

1 ~~(A) In the North Beach Special Use District where such activities are limited to~~
2 ~~15% of the total floor area occupied by the Principal or Conditional Use to which it is accessory unless~~
3 ~~the Principal or Conditional Use is Specialty Foods Manufacturing as defined in Section 780.3 of this~~
4 ~~Code; and~~

5 ~~(B) except that~~ Notwithstanding the floor area limitation in subsection
6 (d)(1), a Catering Use limited to food and beverage Catering shall be permitted as an
7 Accessory Use to Restaurants and Limited Restaurants if the following requirements are met:

8 ~~(iA)~~ The Catering Use does not operate more than 75% of the total time
9 within the Restaurant's or Limited Restaurant's Hours of Operation on any given day; and

10 ~~(iiB)~~ The Catering Use does not distribute or deliver individual meals to
11 customers directly from the subject lot, either by its own means, or through a third-party
12 delivery service.

15 **SEC. 722. NORTH BEACH NEIGHBORHOOD COMMERCIAL DISTRICT.**

16 The North Beach Neighborhood Commercial District is a nonlinear district centered on
17 Columbus Avenue, located in the valley between Telegraph Hill and Russian Hill north of
18 Broadway. North Beach functions as a neighborhood-serving marketplace, citywide specialty
19 shopping, and dining district, and a tourist attraction, as well as an apartment and residential
20 hotel zone. Traditionally, the district has provided most convenience goods and services for
21 residents of North Beach and portions of Telegraph and Russian Hills. North Beach's eating,
22 drinking, and entertainment establishments remain open into the evening to serve a much
23 wider trade area and attract many tourists. The balance between neighborhood-serving
24 convenience stores and Citywide specialty businesses has shifted, as convenience stores
25 have been replaced by restaurants and bars. The proliferation of financial services, limited

1 financial services, and professional services has also upset the district's balance of uses. The
2 relocation of business and professional offices from downtown to North Beach threatens the
3 loss of upper-story residential units.

4 The North Beach District controls are designed to ensure the livability and
5 attractiveness of North Beach. The protection and enhancement of the unique architectural,
6 cultural, and historic character of North Beach shall be prioritized. Building standards limit
7 new development to a small to moderate scale. Rear yards are protected above the ground
8 story and at residential levels. Active commercial uses shall be required at the ground floor.
9 Special controls limit Health Services to small neighborhood-serving medical and dental
10 services, while large-scale medical facilities are prohibited. Small-scale, neighborhood-serving
11 businesses are strongly encouraged and formula retail uses are prohibited. To preserve and
12 maintain the district's small-scale, fine grain storefronts, the consolidation or merger of
13 existing retail or commercial spaces or storefronts ~~are prohibited~~ is restricted, and Use Sizes are
14 controlled to encourage ~~conversion back to the~~ traditional small-scale commercial spaces.
15 Special controls are necessary because an over-concentration of food and beverage service
16 establishments limits neighborhood-serving retail sales and personal services in an area that
17 needs them to thrive as a neighborhood. To honor the importance of Legacy Businesses in
18 the success of the neighborhood, special controls are in place to prevent the replacement of
19 an active Legacy Business with a non-Legacy Business. In order to maintain neighborhood-
20 serving retail sales and personal services and to protect residential livability, additional ~~eating~~
21 ~~and drinking establishments~~ Restaurants and Bars are prohibited in spaces that have been
22 occupied by neighborhood-serving retail sales and personal services. ~~Special controls prohibit~~
23 ~~new walk-up facilities.~~ Financial services, limited financial services, and ground-story business
24 and professional office uses are prohibited from locating in the portion of the district south of
25 Greenwich Street, while new financial services locating in the portion of the district north of

Greenwich Street are limited. Restrictions on automobile and drive-up uses are intended to promote continuous retail frontage and maintain residential livability.

In keeping with the district's existing mixed-use character, housing development in new buildings is encouraged above the ground floor. Existing residential units are protected by prohibitions of upper-story conversions, mergers, removals, and demolitions. Per Section 207.1 of this Code, Accessory Dwelling Units are permitted within the existing building envelope, but may not eliminate or reduce ground-story retail or commercial space.

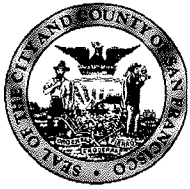

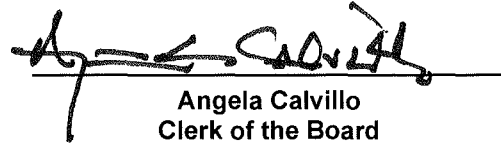

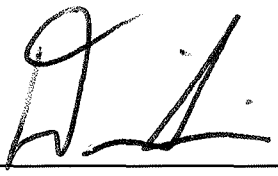
