15 Section 1. The Board of Supervisors hereby adopts and implements the Third
16 Amendment to the 2018-2021 Memorandum of Understanding (“MOU”) between the City and
17 County of San Francisco and the San Francisco Fire Fighters Local 798, Unit 2, to defer wage
18 increases currently set for fiscal year 2020-2021, extend the term by two years, and set
19 wages for the additional term.

20 The Third Amendment to the MOU so implemented is on file with the Clerk of the
21 Board of Supervisors in Board File No. 201046.

23 Section 2. The Board of Supervisors hereby authorizes the Department of Human
24 Resources to make non-substantive ministerial or administrative corrections to the MOU.

1 Section 3. Effective Date. This ordinance shall become effective upon enactment.
2 Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance
3 unsigned or does not sign the ordinance within ten days of receiving it, or the Board of
4 Supervisors overrides the Mayor's veto of the ordinance.
