14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. The Board of Supervisors hereby adopts and implements the First
16 Amendment to the 2019-2022 Memorandum of Understanding (“MOU”) between the City and
17 County of San Francisco and the Service Employees International Union, Local 1021: Staff &
18 Per Diem Nurses, to make administrative amendments to the overtime provisions.

19 The First Amendment to the MOU so implemented is on file with the Clerk of the Board
20 of Supervisors in Board File No. 201052.

21 Section 2. The Board of Supervisors hereby authorizes the Department of Human
22 Resources to make non-substantive ministerial or administrative corrections to the MOU.

23 Section 3. Effective Date. This ordinance shall become effective upon enactment.
24 Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance

2 Supervisors overrides the Mayor's veto of the ordinance.
