- Host Facility (\$824)
- Limited Service Charitable Feeding Operation (\$0)
- Shared Kitchen Complex < 2,000 square feet (\$824)
- Shared Kitchen Complex > 2,000 square feet (\$1,030)

The proposed ordinance would increase the fees for food vending machines from \$177 to \$227 per machine, and the temporary permit for Food Facilities to an amount equivalent to the hourly rate of an Environmental Health Inspector.
