7 WHEREAS, Fireman's Fund Insurance Company has gifted the San Francisco Fire  
8 Department a check in the amount of \$12,000 as part of its Heritage Program; and

9 WHEREAS, The purpose of the Heritage Program is to support firefighters for safer  
10 communities; and

11 WHEREAS, The Fire Department's intent for the use of these funds is to develop a  
12 recruitment video for the Department in its outreach efforts; and

13 WHEREAS, At its regular meeting on Wednesday, February 10, 2016, the Fire  
14 Commission voted to recommend that the Board of Supervisors approve the gift and  
15 authorize the Chief of the Fire Department to accept the donation to the Department; and

16 WHEREAS, The Fire Commission Resolution is on file with the Clerk of the Board of  
17 Supervisors in File No. 161022, which is hereby declared to be a part of this resolution as if  
18 set forth fully herein; now, therefore, be it

19 RESOLVED, That the Board of Supervisors approves the donation and authorize the  
20 Chief of the Fire Department to retroactively accept the gift of \$12,000 from Fireman's Fund  
21 Insurance for use by the San Francisco Fire Department to develop a recruitment video; and,  
22 be it

23 FURTHER RESOLVED, That the Fire Commission and Fire Department extend their  
24 gratitude to Fireman's Fund Insurance Company for the gift to the City and County of San  
25 Francisco in support of the Fire Department and public safety.


