10 WHEREAS, Soares & Sinclair LLC, is seeking the person-to-person, premise-to-
11 premise transfer of a Type-20 off-sale beer and wine liquor license to do business as
12 Willow on the Green, located at 1327B-9th Avenue (District 7); and

13 WHEREAS, The Planning Department has verified that the area is properly
14 zoned and recommends approval; and

15 WHEREAS, The Police Department has filed zero protests and zero letters of
16 support with the Department of Alcoholic Beverage Control under California Business
17 and Professions Code, Section 24013, and recommends that the Department of
18 Alcoholic Beverage Control issue the liquor license with no further conditions; now,
19 therefore, be it

20 RESOLVED, That in accordance with California Business and Professions Code,
21 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
22 hereby determines that the person-to-person, premise-to-premise transfer of a Type-20
23 off-sale beer and wine liquor license to Soares & Sinclair LLC, to do business as Willow
24 on the Green, located at 1327B-9th Avenue, will serve the public convenience or
25 necessity of the City and County of San Francisco; and, be it

1 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
2 San Francisco hereby endorses and adopts the recommendations of the Police
3 Department listed above and recommends that the Department of Alcoholic Beverage
4 Control issue the license with those conditions.
