9 WHEREAS, Upon completion of a competitive selection process, the Airport  
10 Commission adopted Resolution No. 18-0213 on July 10, 2018, awarding the Terminal 1 Food  
11 and Beverage Concession Lease 5 to Tastes on the Fly San Francisco, LLC; and

12 WHEREAS, The Terminal 1 Food and Beverage Concession Lease 5 has a term of ten  
13 years with one two-year option to extend, and an initial minimum annual guarantee of  
14 \$310,000; now, therefore, be it

15 RESOLVED, That this Board of Supervisors hereby approves the Terminal 1 Food and  
16 Beverage Concession Lease 5, a copy of which is on file with the Clerk of the Board of  
17 Supervisors in File No. 181068; and, be it

18 FURTHER RESOLVED, That within 30 days of the lease being fully-executed by all  
19 parties, the Airport Commission shall provide the final lease to the Clerk of the Board for  
20 inclusion into the official file.
