3 **Resolution approving the settlement of unlitigated claim filed by Mignon Dunbar**  
4 **against the City and County of San Francisco for \$70,000; including two charges that**  
5 **were filed with the Department of Fair Employment and Housing, one on November 24,**  
6 **2014, the other on February 4, 2015; the claim involves an employment dispute;**  
7 **additional material terms of the settlement are that Dunbar resigns employment**  
8 **effective August 19, 2016, and that she agrees not to seek or accept future employment**  
9 **with the Police Department.**

11 WHEREAS, Mignon Dunbar filed charges with the Department of Fair Employment and  
12 Housing (DFEH) on November 24, 2014, and February 4, 2015, against the City and County  
13 of San Francisco; and

14 WHEREAS, The claim involves an alleged employment dispute; and


15 WHEREAS, The Police Department (SFPD) has recommended settlement of the claim  
16 by payment of \$70,000 and resignation of Dunbar effective August 19, 2016, and agreement  
17 by Dunbar not to seek or accept future employment with the SFPD; now, therefore, be it

18 RESOLVED, That pursuant to Administrative Code, Section 10.22, the Board of  
19 Supervisors hereby authorizes the City Attorney to settle and compromise the claim by  
20 payment of \$70,000 and agreement by Dunbar to resign and not seek or accept future  
21 employment with the SFPD.


