9 WHEREAS, Upon completion of a competitive selection process, the Airport
10 Commission adopted Resolution No. 18-0234 on August 7, 2018, awarding the Airport
11 Terminal 3 Boarding Area E and International Terminal Boarding Area G Wellness
12 Concession Lease to Spa BR SFO, LLC; and

13 WHEREAS, The Terminal 3 Boarding Area E and International Terminal Boarding Area
14 G Wellness Concession Lease has a term of ten years, and an initial minimum annual
15 guarantee of \$250,000; now, therefore, be it

16 RESOLVED, That this Board of Supervisors hereby approves the Terminal 3 Boarding
17 Area E and International Terminal Boarding Area G Wellness Concession Lease, a copy of
18 which is on file with the Clerk of the Board of Supervisors in File No. 190020; and, be it

19 FURTHER RESOLVED, That within 30 days of the lease being fully-executed by all
20 parties, the Airport Commission shall provide the final lease to the Clerk of the Board for
21 inclusion into the official file.


