

1 [Emergency Declaration - Substructure Support, Inc. - Repairs for Damaged Storm Sewer
2 System - Third Street, between Berry Street and Third Street Bridge - Not to Exceed
3 \$700,000]

4 **Resolution approving the emergency declaration of the Director of Public Works,**
5 **pursuant to Administrative Code, Section 6.60(b), to repair the damaged sewer system**
6 **in the vicinity of Third Street, between Berry Street and the Third Street Bridge, for a**
7 **cost not to exceed \$700,000.**

9 WHEREAS, On September 11, 2018, San Francisco Public Utilities Commission staff
10 observed a damaged sewer system at Third Street between Berry Street and the Third Street
11 Bridge, including significant cracks in the sewer, and severe erosion of soil above the sewer
12 resulting in void spaces; and

13 WHEREAS, Both San Francisco Public Works and the San Francisco Public Utilities
14 Commission further investigated the underground situation to assess the damage at the
15 subject location; and

16 WHEREAS, On October 29, 2018, San Francisco Public Works staff went into the
17 damaged storm sewer and concluded that the damaged storm sewer system needs
18 immediate repair or risks collapsing during the upcoming rainy season and continuous
19 northbound Third Street traffic loading; and

20 WHEREAS, The Director of Public Works has determined these circumstances
21 constitute an imminent threat to the property and potential harm to the surrounding public; and

22 WHEREAS, Under authority granted by Administrative Code, Section 6.60(b), the
23 Director of Public Works declared an emergency on November 2, 2018, and gave notice of
24 the emergency declaration to the Board of Supervisors, Mayor, and Controller; and

1 WHEREAS, San Francisco Public Works staff has analyzed the circumstances
2 extensively and determined that repair work estimated to cost approximately \$700,000.00 is
3 required to ensure safety and minimize risk of collapse; and

4 WHEREAS, Pursuant to Administrative Code, section 6.60(d), the Director Public
5 Works acting as the Mayor's Designee authorized the commencement of emergency work as
6 the estimated cost of the work is in excess of \$250,000; and

7 WHEREAS, San Francisco Public Works anticipates executing an emergency contract
8 with Substructure Support, Inc. for the repairs of the damaged storm sewer; and

9 WHEREAS, The Controller has certified that funds are available for this emergency
10 contract; now, therefore, be it

11 RESOLVED, That the Board of Supervisors hereby approves the emergency
12 declaration for the damaged sewer system made by the Director Public Works on
13 November 2, 2018; and, be it

14 FURTHER RESOLVED, That within thirty (30) days of an emergency contract being full
15 executed by all parties, San Francisco Public Works shall provide a copy of the signed
16 contract to the Clerk of the Board for inclusion into the official file.


