3 **Resolution approving the Harvey Milk Terminal 1 Food and Beverage Historic**  
4 **Restaurant Lease No. 23-0235 between Tastes on the Fly San Francisco, LLC, and**  
5 **the City and County of San Francisco, acting by and through its Airport Commission,**  
6 **for a term of 14 years with one two-year option to extend at the sole discretion of the**  
7 **Airport Commission, and a minimum annual guarantee of \$550,000 for the first year**  
8 **of the Lease, effective upon approval of this Resolution.**

10 WHEREAS, Upon completion of a competitive selection process, on September 19,  
11 2023, by Resolution No. 23-0235, the Airport Commission (Commission) awarded the Harvey  
12 Milk Terminal 1 Food and Beverage Historic Restaurant Lease No. 23-0235 (Lease) to Tastes  
13 on the Fly San Francisco, LLC; and

14 WHEREAS, The Lease has a term of 14 years with one two-year option to extend at  
15 the sole discretion of the Airport Commission, and an initial minimum annual guarantee of  
16 \$550,000; now, therefore, be it

17 RESOLVED, That this Board of Supervisors hereby approves the Harvey Milk Terminal  
18 1 Food and Beverage Historic Restaurant Lease No. 23-0235, a copy of which is on file with  
19 the Clerk of the Board of Supervisors in File No. 231060; and, be it

20 FURTHER RESOLVED, That within thirty (30) days of the Lease being fully executed by  
21 all parties, the Airport Commission shall provide the final lease to the Clerk of the Board for  
22 inclusion into the official file.


