16 Alcoholic Beverage Control issue the liquor license with conditions; and

17 WHEREAS, The Police Department recommends approval with no new  
18 conditions; now, therefore, be it

19 RESOLVED, That in accordance with California Business and Professions Code,  
20 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
21 hereby determines that the issuance of a Type-42 on-sale beer and wine public  
22 premises liquor license to Bin 415 LLC, located at located at 950 Mason Street inside  
23 the Fairmont Hotel (District 3), will serve the public convenience or necessity of the City


