3 **Resolution determining that the issuance of a Type-21 off-sale general beer, wine,**  
4 **and distilled spirits liquor license to Dad & Son's Market, located at 3218 Fillmore**  
5 **Street (District 2), will serve the public convenience or necessity of the City and**  
6 **County of San Francisco; and requesting that the California Department of**  
7 **Alcoholic Beverage Control impose a condition on the issuance of the license.**

9 WHEREAS, Dad & Son's Market is seeking the Type-21 off-sale general beer,  
10 wine, and distilled spirits liquor license, located at 3218 Fillmore Street (District 2); and

11 WHEREAS, The Planning Department has verified that the area is properly  
12 zoned and recommends approval; and

13 WHEREAS, The Police Department has filed 10 protests and 187 letters of  
14 support with the Department of Alcoholic Beverage Control under California Business  
15 and Professions Code, Section 24013, and recommends that the Department of  
16 Alcoholic Beverage Control issue the liquor license with conditions; and

17 WHEREAS, The condition recommended by the Police Department is, as  
18 follows: Petitioner(s) shall actively monitor the area under their control in an effort to  
19 prevent the loitering of persons on any property adjacent to the licensed premises as  
20 depicted on ABC-253; now, therefore, be it

21 RESOLVED, That in accordance with California Business and Professions Code,  
22 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
23 hereby determines that the Type-21 off-sale general beer, wine, and distilled spirits  
24 liquor license to Dad & Son's Market, 3218 Fillmore Street (District 2), will serve the  
25 public convenience or necessity of the City and County of San Francisco; and, be it

1            FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
2 San Francisco hereby endorses and adopts the recommendations of the Police  
3 Department listed above and recommends that the Department of Alcoholic Beverage  
4 Control issue the license with that condition.




