

1 [Accept and Expend Grant - Retroactive - California Department of Insurance - Automobile  
2 Insurance Fraud Program - \$298,336]

3 **Resolution retroactively authorizing the Office of the District Attorney to accept and**  
4 **expend a grant in the amount of \$298,336 from the California Department of**  
5 **Insurance for the Automobile Insurance Fraud Program for the grant period of July 1,**  
6 **2018, through June 30, 2019.**

7  
8 WHEREAS, The Office of the District Attorney applied for funding from the California  
9 Department of Insurance for the "Automobile Insurance Fraud Program" and was awarded  
10 \$298,336; and

11 WHEREAS, The purpose of the grant is to provide enhanced investigation and  
12 prosecution of automobile insurance fraud cases, including the application process and  
13 subsequent reporting requirements as set forth in the California Insurance Code, Section  
14 1872.8, California Code of Regulations, Title 10, Section 2698.60 et seq.; and

15 WHEREAS, This recurring grant was budgeted in the FY2018-2019 and FY2019-2020  
16 Annual Budget and Appropriation Ordinance, Ordinance No. 181-18; and

17 WHEREAS, California Department of Insurance awarded additional FY2018-2019  
18 funds of \$65,664; and

19 WHEREAS, The adopted budget for FY2018-2019 is \$232,672; and

20 WHEREAS, The amount of \$65,664 is required to be appropriated to equal the total  
21 amount of \$298,336 awarded to the Office of the District Attorney for the 2018-19 fiscal year;  
22 and

23 WHEREAS, The grant does not require an amendment to the Annual Salary  
24 Ordinance (ASO) Amendment; and

25 WHEREAS, The grant includes indirect costs of \$22,295; and now, therefore, be it

1 RESOLVED, That should the Office of the District Attorney receive more or less  
2 money than the awarded amount of \$298,336, that the Board of Supervisors hereby  
3 approves the acceptance and expenditure by the Office of the District Attorney of the  
4 additional or reduced money; and, be it

5 FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the Office  
6 of the District Attorney to accept and expend, on behalf of the City and County of San  
7 Francisco, a grant from the California Department of Insurance for the Automobile  
8 Insurance Fraud Program to be funded in part from funds made available through California  
9 Insurance Code, Section 1872.8, California Code of Regulations, Title 10, Section 2698.60  
10 et seq. in the amount of \$298,336 to enhance investigation and prosecution of automobile  
11 insurance fraud cases; and, be it


12 FURTHER RESOLVED, That the District Attorney of the City and County of San  
13 Francisco is authorized, on its behalf, to submit the attached proposal to the California  
14 Department of Insurance and is authorized to execute on behalf of the Board of  
15 Supervisors the attached Grant Award Agreement including any extensions or  
16 amendments thereof; and, be it


17 FURTHER RESOLVED, That it is agreed that any liability arising out of the  
18 performance of the Grant Award Agreement, including civil court actions for damages, shall  
19 be the responsibility of the grant recipient and the authorizing agency; the State of  
20 California and the California Department of Insurance disclaim responsibility for any such  
21 liability; and, be it


22 FURTHER RESOLVED, That the grant funds received hereunder shall not be used  
23 to supplant expenditures controlled by this body.


