10 WHEREAS, Upon the completion of a request for proposals process, the Airport  
11 Commission awarded Terminal 3 Boarding Area F Food and Beverage Concession Lease  
12 No. 16-0315 to the highest-ranking responsive and responsible proposer, Tastes on the Fly  
13 San Francisco, LLC, by Airport Commission Resolution No. 16-0315 adopted December 6,  
14 2016; and

15 WHEREAS, Terminal 3 Boarding Area F Food and Beverage Concession Lease  
16 No. 16-0315 has a term of seven years with two options to extend of one year each for a post-  
17 security concession, and an initial Minimum Annual Guarantee of \$650,000; now, therefore,  
18 be it

19 RESOLVED, That this Board of Supervisors hereby approves Terminal 3 Boarding  
20 Area F Food and Beverage Concession Lease No. 16-0315, a copy of which is on file with the  
21 Clerk of the Board of Supervisors in File No. 170262; and, be it

22 FURTHER RESOLVED, That within thirty days of the Lease being fully-executed by  
23 all parties, the Airport Commission shall provide the final lease to the Clerk of the Board for  
24 inclusion into the official file.
