10 WHEREAS, Upon completion of a competitive selection process, on August 15, 2023,
11 by Resolution No. 23-0197, the Airport Commission (Commission) awarded the Terminal 2
12 Specialty Coffee Café Lease No. 23-0197 (Lease) to Guava and Java SFO, Inc.; and

13 WHEREAS, The Lease has a term of 12 years with two 1-year options to extend the
14 term at the Commission's sole discretion, and an initial minimum annual guarantee of
15 \$420,000; now, therefore, be it

16 RESOLVED, That this Board of Supervisors hereby approves the Terminal 2 Coffee
17 Café Lease No. 23-0197, a copy of which is on file with the Clerk of the Board of Supervisors
18 in File No. 230966; and, be it

19 FURTHER RESOLVED, That within thirty (30) days of the lease being fully executed by
20 all parties, the Commission shall provide the final Lease to the Clerk of the Board for inclusion
21 into the official file.
