

1 [Contract Amendment - Health Right 360 - Residential Substance Use Disorder and Mental  
2 Health Outpatient Services - Not to Exceed \$163,930,879]

3 **Resolution approving Amendment No. 1 to the agreement between Health Right 360**  
4 **and the Department of Public Health (DPH), to provide residential substance use**  
5 **disorder and mental health outpatient services, to increase the agreement by**  
6 **\$79,865,964 for an amount not to exceed \$163,930,879; to extend the term by three**  
7 **years from June 30, 2022, for a total agreement term of July 1, 2018, through June 30,**  
8 **2025; and to authorize DPH to enter into amendments or modifications to the contract**  
9 **prior to its final execution by all parties that do not materially increase the obligations**  
10 **or liabilities to the City and are necessary to effectuate the purposes of the contract or**  
11 **this Resolution.**

13 WHEREAS, The Department of Public Health (DPH), in order to provide mental health  
14 and substance use disorder services for adults residing in San Francisco, conducted two  
15 Request for Proposals (RFP) processes in 2016 and 2017, for Substance Use Disorder  
16 Treatment Services and Support, RFP 26-2016, and Mental Health Outpatient Program for  
17 Adults/Older Adults, RFP 8-2017, awarding a contract to HR360, to provide these services;  
18 and

19 WHEREAS, DPH entered into an agreement on July 1, 2018, to provide these  
20 residential substance use disorder and mental health outpatient services for four years, with  
21 the term of July 1, 2018, through June 30, 2022, in an amount not to exceed \$84,064,915;  
22 and

23 WHEREAS, A copy of the original agreement is on file with the Clerk of the Board of  
24 Supervisors in File No. 180829; and

1           WHEREAS, DPH wishes to amend the agreement to continue providing residential  
2 substance use disorder and mental health outpatient services by extending the term by three  
3 years, from June 30, 2022, through June 30, 2025, increasing the contract by \$79,865,964 for  
4 a total contract amount not to exceed \$163,930,879 and for a total agreement term of July 1,  
5 2018, through June 30, 2025; and

6           WHEREAS, Section 9.118 of the Charter requires approval of the Board of Supervisors  
7 for contracts requiring anticipated expenditures exceeding \$10 million; now, therefore, be it

8           RESOLVED, That the Board of Supervisors hereby authorizes the Director of Public  
9 Health and the Director of the Office of Contract Administration/Purchaser, on behalf of the  
10 City and County of San Francisco, to execute Amendment No. 1 to the agreement with Health  
11 Right 360 to provide residential substance use disorder and mental health outpatient services,  
12 to extend the term by three years, from June 30, 2022, for a total agreement term of July 1,  
13 2018, through June 30, 2025, and increasing the contract by \$79,865,964, for a total contract  
14 amount not to exceed \$163,930,879; and, be it

15           FURTHER RESOLVED, That the Board of Supervisors authorizes the Department of  
16 Public Health to enter into any amendments or modifications to the contract, prior to its final  
17 execution by all parties, that the Department determines, in consultation with the City  
18 Attorney, are in the best interests of the City, do not otherwise materially increase the  
19 obligations or liabilities of the City, are necessary or advisable to effectuate the purposes of  
20 the contract, and are in compliance with all applicable laws; and be it

21           FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed  
22 by all parties, the Director of Health and/or the Director of the Office of Contract  
23 Administration/Purchaser shall provide the final contracts to the Clerk of the Board for inclusion  
24 into the official File No. 220415
