Resolution approving Amendment No. 2 to the agreement between Westside Community Mental Health Center, Inc. and the Department of Public Health (DPH), for substance use disorder services; to increase the agreement by \$6,526,688 for an amount not to exceed \$15,580,935; to extend the term by three years from June 30, 2023, for a total agreement term of July 1, 2017, through June 30, 2026; and to authorize DPH to enter into amendments or modifications to the contract prior to its final execution by all parties that do not materially increase the obligations or liabilities to the City and are necessary to effectuate the purposes of the contract or this Resolution.

WHEREAS, The Department of Public Health (DPH), selected Westside Community Mental Health Center, Inc. (Westside) through a Request for Proposal process, RFP 26-2016, issued on September 27, 2016, in order to provide methadone maintenance and support services; and

WHEREAS, DPH wishes to amend the agreement to continue providing methadone maintenance and support services with the length of the term anticipated in RFP 26-2016, by extending the term by three years, from June 30, 2023, through June 30, 2026, increasing the contract by \$6,526,688 for a total contract amount not to exceed \$15,580,935 and for a total agreement term of July 1, 2017, through June 30, 2026; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby authorizes the Director of Public Health and the Director of the Office of Contract Administration/Purchaser, on behalf of the City and County of San Francisco, to execute Amendment No. 2 to the agreement with Westside for methadone maintenance and support services, increasing the contract

by \$6,526,688, for a total contract amount not to exceed \$15,580,935 and for a total agreement term of July 1, 2017, through December 31, 2026; and, be it

FURTHER RESOLVED, That the Board of Supervisors authorizes the Department of Public Health to enter into any amendments or modifications to the contract, prior to its final execution by all parties, that the Department determines, in consultation with the City Attorney, are in the best interests of the City, do not otherwise materially increase the obligations or liabilities of the City, are necessary or advisable to effectuate the purposes of the contract, and are in compliance with all applicable laws; and, be it


