

1 [Accept and Expend Grant - Centers for Disease Control and Prevention - San Francisco STD  
2 Surveillance Network Project - \$225,000]

3 **Resolution retroactively authorizing the Department of Public Health to accept and**  
4 **expend a grant increase of \$75,000 for a total amount of \$225,000 from the Department**  
5 **of Health and Human Services, Centers for Disease Control and Prevention to**  
6 **participate in a program entitled San Francisco STD Surveillance Network Project for**  
7 **the period of September 30, 2016, through September 29, 2017.**

9 WHEREAS, Department of Health and Human Services, Centers for Disease Control  
10 and Prevention has agreed to fund Department of Public Health (DPH) in the amount of  
11 \$225,000 for the period of September 30, 2016, through September 29, 2017; and

12 WHEREAS, The full project period of the grant starts on September 30, 2013, and  
13 ends on September 29, 2018, with year five subject to availability of funds and satisfactory  
14 progress of the project; and

15 WHEREAS, The purpose of this project continues its on-going use of staff expertise in  
16 STD surveillance & epidemiology to enhance the understanding of STD trends &  
17 determinants, improving the ability to monitor health outcomes & develop effective  
18 interventions to reduce morbidity; and

19 WHEREAS, The grant does not require an Annual Salary Ordinance Amendment; and

20 WHEREAS, A request for retroactive approval is being sought because DPH received  
21 the full award agreement on January 31, 2017, for a project start date of September 30, 2016;  
22 and

23 WHEREAS, The AAO budget for FY2016-2017 was approved in the amount of  
24 \$150,000; and

1           WHEREAS, An increase of \$75,000 from \$150,000 was approved for the period of  
2 September 30, 2016, through September 29, 2017, for a total amount of \$225,000; and

3           WHEREAS, The budget includes a provision for indirect costs in the amount of \$1,485;  
4 now, therefore, be it


5           RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant  
6 in the amount of \$225,000 from Department of Health and Human Services, Centers for  
7 Disease Control and Prevention; and, be it

8           FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and  
9 expend the grant funds pursuant to San Francisco Administrative Code, Section 10.170-1;  
10 and, be it


11           FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
12 Agreement on behalf of the City.



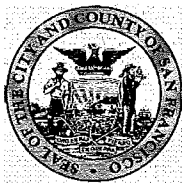
