5 **support the Community Resource Directory and Behavioral Health Project, for the**
6 **period of July 1, 2023, through June 30, 2025.**

8 WHEREAS, The Epic Systems Corporation (ESC) has donated to the San Francisco
9 Department of Public Health (DPH) in the amount of \$37,500 to support the Community
10 Resource Directory and Behavioral Health Project; and

11 WHEREAS, The Community Resource Directory allows for closed-loop referrals to
12 social care with independent community organizations; and

13 WHEREAS, The Behavioral Health Project will create a single patient record across
14 physical and behavioral health while improving referrals and coordination between the
15 physical and mental health divisions of our organization; and

16 WHEREAS, The ESC provides gifts to entities that help low income and at-risk
17 populations; now, therefore, be it

18 RESOLVED, That the Board of Supervisors approves the gift and authorizes DPH to
19 accept and expend a gift of cash in the value of \$37,500 donated by ESC; and, be it

20 FURTHER RESOLVED, That the proceeds of the gift by ESC will be accepted and
21 expended consistent with the San Francisco Administrative Code, Sections governing the
22 acceptance of gifts to the City and County of San Francisco, including the San Francisco
23 Administrative Code, Section 10.100-305; and, be it

24 FURTHER RESOLVED, That the Board of Supervisors extends its gratitude to ESC for
25 the generous gift to the City and County of San Francisco in support of DPH.
