6 **reimbursement under the State Medi-Cal County Inmate Program, (1) Participation**  
7 **Agreement 20-MCIPSANFRANCISCO-38 effective July 1, 2020, and (2) Administrative**  
8 **Services Agreement No. 20-10239 for the period of July 1, 2020, through June 30, 2023,**  
9 **for an amount not to exceed \$21,504.33.**

11 WHEREAS, The Department of Public Health (DPH) is responsible for the provision of  
12 health care services to inmates of the City and County of San Francisco jails; and

13 WHEREAS, The costs of providing health care to inmates are supported the California  
14 Medical Assistance Program (Medi-Cal), which includes the Medi-Cal County Inmate Program  
15 (MCIP); and

16 WHEREAS, The Department of Health Care Services (DHCS) is the single State  
17 agency responsible for administering Medi-Cal and MCIP; and

18 WHEREAS, In order to receive MCIP reimbursement and funding, DHCS requires  
19 approval of Participation Agreements and Administrative Services Agreements between  
20 DHCS and local county health agencies by the agencies' local county boards of supervisors;  
21 and

22 WHEREAS, The Participation Agreement will enable DHCS to pay providers of  
23 services to San Francisco Medi-Cal County Inmate Program beneficiaries and will obligate  
24 DPH to reimburse DHCS for the non-federal MCIP services paid by DHCS, except where the  
25 County incurs the cost for MCIP services; and

1           WHEREAS, The Administrative Services Agreement No. 20-10239 will obligate DPH to  
2 reimburse DHCS for San Francisco’s share of non-federal MCIP administrative services, as  
3 DHCS requires; now, therefore, be it

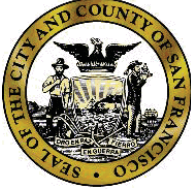
4           RESOLVED, That the DPH is hereby retroactively authorized to enter into DHCS Medi-  
5 Cal County Inmate Program Participation Agreement 20-MCIPSANFRANCISCO-38 and  
6 DHCS Administrative Services No. 20-10239; and, be it

7           FURTHER RESOLVED, That within thirty (30) days of the agreements being fully  
8 executed by all parties, the SFDPH shall provide the agreements to the Clerk of the Board for  
9 inclusion into the official file.
