3 **Resolution approving the grant agreement between the City and County of San**
4 **Francisco and the non-profit Institute On Aging, for the provision of the Community**
5 **Living Fund program, for the period of July 1, 2023, through June 30, 2025, for a total**
6 **not to exceed amount of \$11,414,740.**

8 WHEREAS, The City and County of San Francisco, by and through its Human Services
9 Agency, wishes to provide the Community Living Fund program to San Francisco older adults
10 and adults with disabilities; and

11 WHEREAS, The Human Services Agency conducted a Request for Proposals #1050
12 for The Community Living Fund Program in January 2023; and

13 WHEREAS, Institute On Aging submitted a proposal, and was awarded the grant for
14 the total not to exceed amount of \$22,750,279 for the period of July 1, 2023, through June 30,
15 2027; and

16 WHEREAS, On April 5, 2023, the Department of Disability and Aging Services
17 Commission approved the Community Living Fund grant with Institute On Aging in the total
18 not to exceed amount of \$22,750,279 for the period from July 1, 2023, through June, 30,
19 2027; and

20 WHEREAS, Charter, Section 9.118(b) provides that agreements entered into by a
21 department requiring expenditures exceeding ten million dollars shall be subject to approval
22 by the Board of Supervisors; and

23 WHEREAS, The Human Services Agency wishes to enter into a grant agreement with
24 Institute On Aging for the period from July 1, 2023, through June 30, 2025, for a total not to
25 exceed amount of \$11,414,740; now, therefore, be it

1 RESOLVED, That the Board of Supervisors hereby authorizes the grant agreement
2 between the City and County of San Francisco and Institute On Aging to provide the
3 Community Living Fund program during the period of July 1, 2023, through June 30, 2025, for
4 a total not to exceed amount of \$11,414,740; and, be it

5 FURTHER RESOLVED, That within thirty (30) days of the agreement being fully
6 executed by all parties, the Human Services Agency shall provide the final grant agreement to
7 the Clerk of the Board for inclusion into the official file.
