

[Liquor License Transfer - 1799 Union Street - Bottles and Bites]

**Resolution determining that the person-to-person, premise-to-premise transfer of a Type-21 off-sale general beer, wine, and distilled spirits liquor license to Bottles and Bites LLC., doing business as Bottles and Bites, located at 1799 Union Street (District 2), will serve the public convenience or necessity of the City and County of San Francisco, in accordance with California Business and Professions Code, Section 23958.4; and requesting that the California Department of Alcoholic Beverage Control impose a condition on the issuance of the license.**

WHEREAS, Bottles and Bites LLC, is seeking the person-to-person, premise-to-premise transfer of a Type-21 off-sale general beer, wine, and distilled spirits liquor license to do business as Bottles and Bites, located at 1799 Union Street (District 2); and

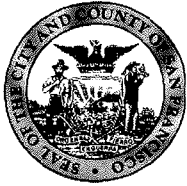
WHEREAS, The Planning Department has verified that the area is properly zoned and recommends approval; and

WHEREAS, The Police Department has filed two protests and zero letters of support with the Department of Alcoholic Beverage Control under California Business and Professions Code, Section 24013, and recommends that the Department of Alcoholic Beverage Control issue the liquor license with a condition; and

WHEREAS, The condition recommended by the Police Department are the following: 1) Petitioner(s) shall actively monitor the area under their control in an effort to prevent the loitering of persons on any property adjacent to the licensed premises as depicted on the ABC-253; now, therefore, be it

1           RESOLVED, That in accordance with California Business and Professions Code,  
2           Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
3           hereby determines that the person-to-person, premise-to-premise transfer of a Type-21  
4           off-sale general beer, wine, and distilled spirits liquor license to Bottles and Bites LLC.,  
5           doing business as Bottles and Bites, located at 1799 Union Street, will serve the public  
6           convenience or necessity of the City and County of San Francisco; and, be it

7           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
8           San Francisco hereby endorses and adopts the recommendation of the Police  
9           Department listed above and recommends that the Department of Alcoholic Beverage  
10          Control issue the license with that condition.


