3 **Resolution determining that the issuance of a Type-64 special on-sale general**  
4 **theater liquor license to THELOSTCHURCH.ORG, INC, located at 665 Chestnut**  
5 **Street (District 3), will serve the public convenience or necessity of the City and**  
6 **County of San Francisco, in accordance with California Business and**  
7 **Professions Code, Section 23958.4; and requesting that the California Department**  
8 **of Alcoholic Beverage Control impose conditions on the issuance of the license.**

10 WHEREAS, THELOSTCHURCH.ORG, INC. is seeking the issuance of Type-64  
11 special on-sale general theater liquor license, located at 665 Chestnut Street (District 3);  
12 and

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned and recommends approval; and

15 WHEREAS, The Police Department has filed zero protests and zero letters of  
16 support with the Department of Alcoholic Beverage Control under California Business  
17 and Professions Code, Section 24013, and recommends that the Department of  
18 Alcoholic Beverage Control issue the liquor license with conditions; and

19 WHEREAS, The conditions recommended by the Police Department are the  
20 following: 1) Petitioner( s) shall actively monitor the area under their control in an effort  
21 to prevent the loitering of persons on any property adjacent to the licensed premises as  
22 depicted on ABC-253. 2) The sale of alcoholic beverages for off-sale consumption is  
23 strictly prohibited. 3) No noise shall be audible at any nearby residence; now, therefore,

1           RESOLVED, That in accordance with California Business and Professions Code,  
2 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
3 hereby determines that the issuance of Type-64 special on-sale general theater liquor  
4 license to THELOSTCHURCH.ORG, INC, located at 665 Chestnut Street (District 3),  
5 will serve the public convenience or necessity of the City and County of San Francisco;  
6 and, be it

7           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
8 San Francisco hereby endorses and adopts the recommendations of the Police  
9 Department listed above and recommends that the Department of Alcoholic Beverage  
10 Control issue the license with those conditions.
