11 WHEREAS, Bebidas Bananas, LLC is seeking the premise-to-premise transfer of
12 a Type-21 off-sale general beer, wine, and distilled spirits liquor license for a proposed
13 sales premise doing business as CloudKitchens, located at 475-6th Street (District 6);

15 WHEREAS, The Planning Department has verified that the area is properly
16 zoned and recommends approval; and

17 WHEREAS, The Police Department has filed zero protests and zero letters of
18 support with the Department of Alcoholic Beverage Control under California Business
19 and Professions Code, Section 24013, and recommends that the Department of
20 Alcoholic Beverage Control issue the liquor license with conditions; and

21 WHEREAS, The site is located in an area with an undue concentration of liquor
22 licenses; now, therefore, be it

23 RESOLVED, That the issuance of a Type-21 off-sale general beer, wine, and


