3 **Resolution determining that the transfer of a Type 48 on-sale general public**  
4 **premises license from 86-2<sup>nd</sup> Street to 65 Post Street (District 3) to M&M Group**  
5 **Assets, Inc. dba Dada Bar and Lounge, will serve the public convenience or**  
6 **necessity of the City and County of San Francisco in accordance with California**  
7 **Business and Professions Code, Section 23958.4, and recommending that the**  
8 **California Department of Alcoholic Beverage Control impose conditions on the**  
9 **issuance of the license.**

11 WHEREAS, M&M Group Assets, Inc. is seeking the transfer of a Type 48 on-sale  
12 general public premises license dba Dada Bar and Lounge located at 65 Street (District  
13 3); and

14 WHEREAS, The Planning Department has verified that the area is properly  
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed one (1) protest with the Department  
17 of Alcoholic Beverage Control under California Business and Professions Code, Section  
18 24013, and recommends that the Department of Alcoholic Beverage Control issue the  
19 liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department, as  
21 amended, are the following: 1) the sale of alcoholic beverages for consumption off the  
22 premises is strictly prohibited; 2) the petitioner(s) shall be responsible for maintaining  
23 free of litter the area adjacent to the premises over which they have control, as depicted  
24 on the ABC-257, dated 04/14/2016; 3) no noise shall be audible beyond the area under  
25 the control of the petitioner(s) as defined on the ABC-257, dated 04/14/2016; 4) sales,

1 service or consumption of alcoholic beverages shall be permitted only between the  
2 hours of 9:00 a.m. and 2:00 a.m. daily; and 5) petitioner(s) shall regularly police the  
3 area under their control in an effort to prevent the loitering of persons on or about the  
4 premises; and, be it

5           RESOLVED, That in accordance with California Business and Professions Code,  
6 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
7 hereby determines that the transfer of a Type 48 on-sale general public premises  
8 license from 86-2nd Street to 65 Street (District 3), to M&M Group Assets, Inc. dba  
9 Dada Bar and Lounge, will serve the public convenience or necessity of the City and  
10 County of San Francisco; and, be it

11           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
12 San Francisco hereby endorses and adopts the recommendations of the Police  
13 Department listed above, and recommends that the Department of Alcoholic Beverage  
14 Control issue the license with those conditions.


