2 to Exceed \$19,522,294]

3 **Resolution retroactively approving the award of Professional Services Agreement,**  
4 **Airport Contract No. 50085, to FSP PPM Management, LLC, to manage and staff the**  
5 **Curbside Management Program in an amount not-to-exceed \$19,522,294 for a period of**  
6 **four years beginning July 1, 2016, through June 30, 2020, with one one-year renewal**  
7 **option, pursuant to Charter, Section 9.118(b).**

9 WHEREAS, The Airport has a complex and highly competitive commercial ground  
10 transportation system that serves millions of Airport patrons annually, requiring coordination,  
11 dispatch and monitoring services; and

12 WHEREAS, The day-to-day operations required in the Airport's Curbside Management  
13 Program are administered through a professional services contract; and

14 WHEREAS, Pursuant to Airport Commission Resolution No. 15-0269, Airport staff  
15 prepared and issued a Request for Proposal (RFP) seeking qualified and experienced  
16 contractors to manage and staff the Airport's Curbside Management Program and enter into  
17 contract negotiations with the highest scoring proposer; and

18 WHEREAS, Proposals from FSP PPM Management, LLC, and SP Plus Airport  
19 Services were submitted by the due date, were deemed responsive and were evaluated by a  
20 four-person panel, consistent with the evaluation criteria; and

21 WHEREAS, FSP PPM Management, LLC, was the highest ranked proposer; and

22 WHEREAS, The Airport entered into contract negotiations with FSP PPM  
23 Management, LLC, on May 25, 2016, and reached an agreement on June 7, 2016; and

24 WHEREAS, On June 16, 2016, by Resolution 16-0181 the Airport Commission  
25 approved the award of Professional Services Contract No. 50085 to FSP PPM Management,

1 LLC, to manage and staff the Airport's Curbside Management Program in an amount not to  
2 exceed \$19,522,294 for a period of four (4) years effective July 1, 2016 with one (1) one-year  
3 renewal option; and

4           RESOLVED, That the Board of Supervisors hereby approves the award of Professional  
5 Services Agreement, Airport Contract 50085, to FSP PPM Management, LLC, to manage and  
6 staff the Curbside Management Program in an amount not-to-exceed \$19,522,294 for a  
7 period of four (4) years, retroactive to July 1, 2016, ending June 30, 2020, with one (1) one-  
8 year renewal option, copies of which are contained in Board of Supervisors' File No. 160741;  
9 and, be it

10           FURTHER RESOLVED, That within thirty days of the Agreement being fully executed  
11 by all parties, the Airport Commission shall provide the final document to the Clerk of the  
12 Board for inclusion into the official file.






