3 **Resolution determining that the issuance of an extension on premise of a Type-42**
4 **on-sale beer and wine public premises license to Rachel Cheng for Zaza Nail Spa,**
5 **located at 543-2nd Street (District 6), will serve the public convenience or**
6 **necessity of the City and County of San Francisco, in accordance with California**
7 **Business and Professions Code, Section 23958.4; and recommending that the**
8 **California Department of Alcoholic Beverage Control impose conditions on the**
9 **issuance of the license.**

11 WHEREAS, Rachel Cheng is seeking the issuance of a Type-42 on-sale beer
12 and wine public premises license for Zaza Nail Spa located at 543-2nd Street
13 (District 6); and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

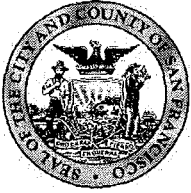
16 WHEREAS, The Police Department has filed zero (0) protests and zero (0)
17 letters of support with the Department of Alcoholic Beverage Control under California
18 Business and Professions Code, Section 24013, and recommends that the Department
19 of Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the
21 following: 1) sales, service, and consumption of alcoholic beverages shall be permitted
22 only between the hours of 10:00 a.m. and 10:00 p.m. each day of the week; 2) no
23 person under the age of 21 shall sell or deliver alcoholic beverages; and 3) sale and
24 service of alcoholic beverages on said patio/terrace/other area shall be restricted to
25 waiter/waitress service and only to patrons seated at a table; now, therefore, be it

1 RESOLVED, That in accordance with California Business and Professions Code,
2 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
3 hereby determines that the issuance of an extension on premise of a Type-42 on-sale
4 beer and wine public premises license to Rachel Cheng for Zaza Nail Spa, located at
5 543-2nd Street (District 6), will serve the public convenience or necessity of the City and
6 County of San Francisco; and, be it

7 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
8 San Francisco hereby endorses and adopts the recommendations of the Police
9 Department listed above and recommends that the Department of Alcoholic Beverage
10 Control issue the license with those conditions.


