2 Operations and Maintenance of the Baggage Handling System in the Harvey Milk Terminal -
3 Not to Exceed \$21,000,000]

4 **Resolution approving Professional Services Agreement, Contract No. 50195, between**
5 **BEUMER Lifecycle Management, LLC, and the City and County of San Francisco,**
6 **acting by and through its Airport Commission, for the operations and maintenance of**
7 **the baggage handling System in the Harvey Milk Terminal, for a total not to exceed**
8 **contract amount of \$21,000,000 for a term of two years and eleven months**
9 **commencing August 1, 2020, through June 30, 2023, pursuant to Charter, Section**
10 **9.118(b).**

12 WHEREAS, On June 16, 2020, pursuant to Resolution No. 20-0111, the Airport
13 Commission awarded the Professional Services Agreement (PSA) for Airport Contract No.
14 50195 for the Operations and Maintenance of the Baggage Handling System in the Harvey
15 Milk Terminal (Terminal 1) to BEUMER Lifecycle Management LLC, for a total not-to-exceed
16 contract amount of \$21,000,000 for a term of two years and eleven months commencing
17 August 1, 2020, through June 30, 2023, with Board of Supervisors' approval in accordance
18 with Charter Section 9.118(b); and

19 WHEREAS, On February 4, 2020, the Office of Contract Administration approved
20 Proprietary Article No. 12 for this Agreement for the procurement of operations and
21 maintenance services of the baggage handling system equipment in Terminal 1, including
22 service and parts when repairs must be done by the manufacturer of the system, as well as
23 access to proprietary software, under Administrative Code, Chapter 21.5(d); and

24 WHEREAS, Charter, Section 9.118(b), provides that agreements entered into by a
25 department, board or commission requiring anticipated expenditures by the City and County

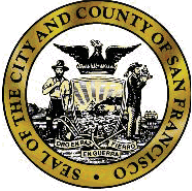
1 of ten million dollars, or a modification to such an agreement having an impact of more than
2 \$500,000, shall be subject to approval by the Board of Supervisors by resolution; and

3 WHEREAS, The Contract is on file with the Clerk of the Board of Supervisors in File
4 No. 200698, which is hereby declared to be a part of this Resolution as if set forth fully
5 herein; now, therefore, be it

6 RESOLVED, That the Board of Supervisors hereby approves Contract No. 50195 for
7 the Operations and Maintenance of the Baggage Handling System in the Harvey Milk
8 Terminal with BEUMER Lifecycle Management, LLC, for a total not to exceed contract amount
9 of \$21,000,000 for a term of two years and eleven months commencing August 1, 2020; and,
10 be it

11 FURTHER RESOLVED, That within thirty (30) days of the Contract being fully
12 executed by all parties, the Airport Commission shall provide it to the Clerk of the Board for
13 inclusion in the official file.
