10 WHEREAS, The San Francisco Police Community Foundation (SFPCF) is a
11 501(c)(3) non-profit organization dedicated to supporting the Police Department while
12 helping to strengthen connectivity between officers and the broader communities they
13 serve; and

14 WHEREAS, The Police Department applied for funding and was awarded a total of
15 \$866,500 to be distributed among the ten Police Department district stations to support
16 officer wellness events and initiatives, community engagement events; and provide
17 equipment to the district stations; and

18 WHEREAS, The gifts will serve a dual purpose of improving police officer wellness,
19 and fostering community support and engagement, and

20 WHEREAS, The Police Department will receive support for officer wellness events
21 and initiatives and station equipment from SFPCF, including but not limited to: a vending
22 machine, sound system, refrigerator, ice machine, massage chair and coffee machine;

1 WHEREAS, Under Administrative Code, Section 10.100.305, the Police
2 Department must obtain Board of Supervisors' approval to accept a donation with a
3 market value of more than \$10,000; now, therefore, be it:

4 RESOLVED, That the Police Department is authorized to accept and expend
5 various gifts valued at approximately \$866,500 to support officer wellness events and
6 initiatives, community engagement events, and to provide station equipment, including an
7 ice machine, massage chair, and coffee machine.

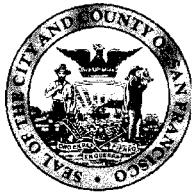
