3 **Resolution determining that the transfer of a Type-21 off-sale general beer, wine,**
4 **and distilled spirits liquor license to Albeco, Inc., doing business as Mollie**
5 **Stone's Market, located at 1600 Jackson Street (District 3), will serve the public**
6 **convenience or necessity of the City and County of San Francisco, in accordance**
7 **with California Business and Professions Code, Section 23958.4; and requesting**
8 **that the California Department of Alcoholic Beverage Control impose a condition**
9 **on the issuance of the license.**

11 WHEREAS, Albeco, Inc., is seeking the transfer of a Type-21 off-sale general
12 beer, wine, and distilled spirits liquor license to do business as Mollie Stone’s Market,
13 located at 1600 Jackson Street (District 3); and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero protests and zero letters of
17 support with the Department of Alcoholic Beverage Control under California Business
18 and Professions Code, Section 24013, and recommends that the Department of
19 Alcoholic Beverage Control issue the liquor license with conditions; and

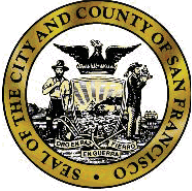
20 WHEREAS, Police Department is recommending approval with the following
21 condition: 1) Petitioner(s) shall actively monitor the area under their control in an effort
22 to prevent the loitering of persons on any property adjacent to the licensed premises as
23 depicted on ABC-253; now, therefore, be it

24 RESOLVED, That in accordance with California Business and Professions Code,
25 Section 23958.4, the Board of Supervisors of the City and County of San Francisco

1 hereby determines that the transfer of a Type-21 off-sale general beer, wine, and
2 distilled spirits liquor license to Albeco, Inc., doing business as Mollie Stone's Market,
3 located at 1600 Jackson Street, will serve the public convenience or necessity of the
4 City and County of San Francisco; and, be it

5 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
6 San Francisco hereby endorses and adopts the recommendations of the Police
7 Department listed above and recommends that the Department of Alcoholic Beverage
8 Control issue the license with the condition.
