WHEREAS, Transportation Code, Article 6 provides for the temporary use and occupancy of a public street for events receiving a permit from the Interdepartmental Staff Committee on Traffic and Transportation (ISCOTT); and

WHEREAS, Transportation Code, Section 6.7 provides that the temporary use or occupancy of a public street shall not unnecessarily obstruct or bar public access onto said street, and that sidewalks shall remain open at all times for pedestrian use unless closure of the sidewalk is provided by Resolution of the Board of Supervisors explaining the reason for such closure; and

WHEREAS, Dreamforce is an annual event sponsored by Salesforce, taking place in the City since 2003; and

WHEREAS, Dreamforce 2024 is anticipated to bring tens of thousands of visitors to the City and take place at the Moscone Center and surrounding streets for over four days; and

WHEREAS, the Board of Supervisors determines that the closure of the sidewalks for Dreamforce 2024 on both sides of Howard Street between 3rd Street and 4th Street, September 14th through September 20, 2024, is necessary to facilitate the event; and

WHEREAS, Authorization for the temporary closure of the above sidewalks is subject to ISCOTT issuing a permit for the event; and

WHEREAS, This Resolution is not a stand-alone authorization to close the subject sidewalks; any as such closure is subject to ISCOTT approving an event permit for

Dreamforce that authorizes closure of the subject sidewalks and is subject to the City's discretionary adoption of California Environmental Quality Act Findings for the project, following review and consideration of completed project related environmental analysis, where required; now, therefore, be it

RESOLVED, That the Board of Supervisors authorizes the temporary closure of the sidewalks on both sides of Howard Street between 3rd Street and 4th Street, for the period of September 14th through September 20, 2024, subject to ISCOTT issuing a permit for the event.
