

1 [Temporary Sidewalk Closure - Dreamforce 2024 on Both Sides of Howard Street Between  
2 3rd Street and 4th Street]

3 **Resolution authorizing the temporary closure of the public sidewalk on both sides of**  
4 **Howard Street between 3rd Street and 4th Street, for the period of September 14**  
5 **through September 20, 2024, subject to ISCOTT issuing a permit for the event.**

7 WHEREAS, Transportation Code, Article 6 provides for the temporary use and  
8 occupancy of a public street for events receiving a permit from the Interdepartmental Staff  
9 Committee on Traffic and Transportation (ISCOTT); and

10 WHEREAS, Transportation Code, Section 6.7 provides that the temporary use or  
11 occupancy of a public street shall not unnecessarily obstruct or bar public access onto said  
12 street, and that sidewalks shall remain open at all times for pedestrian use unless closure of  
13 the sidewalk is provided by Resolution of the Board of Supervisors explaining the reason for  
14 such closure; and

15 WHEREAS, Dreamforce is an annual event sponsored by Salesforce, taking place in  
16 the City since 2003; and

17 WHEREAS, Dreamforce 2024 is anticipated to bring tens of thousands of visitors to the  
18 City and take place at the Moscone Center and surrounding streets for over four days; and

19 WHEREAS, the Board of Supervisors determines that the closure of the sidewalks for  
20 Dreamforce 2024 on both sides of Howard Street between 3rd Street and 4th Street,  
21 September 14th through September 20, 2024, is necessary to facilitate the event; and

22 WHEREAS, Authorization for the temporary closure of the above sidewalks is subject  
23 to ISCOTT issuing a permit for the event; and

24 WHEREAS, This Resolution is not a stand-alone authorization to close the subject  
25 sidewalks; any as such closure is subject to ISCOTT approving an event permit for

1 Dreamforce that authorizes closure of the subject sidewalks and is subject to the City's  
2 discretionary adoption of California Environmental Quality Act Findings for the project,  
3 following review and consideration of completed project related environmental analysis, where  
4 required; now, therefore, be it

5 RESOLVED, That the Board of Supervisors authorizes the temporary closure of the  
6 sidewalks on both sides of Howard Street between 3rd Street and 4th Street, for the period of  
7 September 14th through September 20, 2024, subject to ISCOTT issuing a permit for the  
8 event.


