WHEREAS, Charter, Section 9.118(b), requires the Board of Supervisors to approve by Resolution contracts estimated to cost the City \$10,000,000 or more; and

WHEREAS, The contract referenced above is on file with the Clerk of the Board of Supervisors in File No. 220923, which is hereby declared to be part of this Resolution as if set forth fully herein; and

WHEREAS, This Contract was competitively procured as required by Administrative Code, Chapter 21.1, through an Invitation for Bids issued by the Office of Contract Administration on April 2, 2019, under Sourcing Event 0000001515 for the provision of Biosolids and Grit Hauling Services; and

WHEREAS, Sourcing Event 0000001515 resulted in the primary award of Aggregate 1 to Denali Water Solutions as the lowest responsive bidder (PeopleSoft Contract ID 1000015461) with an LBE subcontracting participation requirement of 7%; and

WHEREAS, Amendment 1 to the contract executed on April 13, 2022 decreased the Not to Exceed (NTE) amount from \$8,700,000 to \$8,600,000; and

WHEREAS, Annually, the Oceanside and Southeast wastewater treatment plants produce approximately 60,000 tons of biosolids which are nutrient rich solids produced during wastewater and 4,000 tons of grit which is sand removed from the wastewater before treatment; and

WHEREAS, The hauling of biosolids and grit from San Francisco Public Utilities
Commission's (SFPUC) Oceanside and Southeast wastewater treatment plants is critical
for the daily operation of the City's wastewater treatment infrastructure; now, therefore,
be it

RESOLVED, That the Board of Supervisors, under Charter, Section 9.118(b), hereby authorizes the Purchaser and Director of the Office of Contract Administration to enter into amend PeopleSoft Contract ID 1000015461 between the City and County of San Francisco and Denali Water Solutions LLC for the hauling of biosolids and grit from PUC's Oceanside and Southeast wastewater treatment plants, increasing the contract amount by \$10,200,000 for a total not to exceed amount of \$18,800,000 and extending the contract end date by four years to September 30, 2026, with a total contract duration of seven years; and, be it

FURTHER RESOLVED, That within 30 days of the contracts being fully executed by all parties, the Purchaser shall provide the final copies of the contracts to the Clerk of the Board for inclusion into the official file.
