9 WHEREAS, The Electorate of the City and County of San Francisco passed
10 Proposition J in November 1976, allowing City and County Departments to contract with
11 private companies for specific services that can be performed for a lower cost than similar
12 work by City and County employees (Charter, Section 10.104.15); and

13 WHEREAS, The Controller has determined that a Purchaser's award of a contract for
14 the services listed below to a private contractor will continue to achieve substantial cost
15 savings for the City; and

16 WHEREAS, The Controller's certification, which confirms that said services can be
17 performed at lower costs to the City and County by private contractor than by employees of
18 the City and County, is on file with the Clerk of the Board of Supervisors in File No. 240613,
19 which is hereby declared to be part of this Resolution as if set forth fully herein; now,
20 therefore, be it

21 RESOLVED, That the Board of Supervisors hereby concurs with the Controller's
22 certification and approves the Proposition J Resolution concerning the Purchaser's award of
23 a contract to a private contractor for the services listed below for the period of July 1, 2024,
24 through June 30, 2025.
