3 **Resolution determining that the premise-to-premise transfer of the Type-48 on-**
4 **sale general public premises liquor license to Angry Otter, Inc., doing business**
5 **as Tonic, located at 895 Post Street (District 6), will serve the public convenience**
6 **or necessity of the City and County of San Francisco, in accordance with**
7 **California Business and Professions Code, Section 23958.4; and requesting that**
8 **the California Department of Alcoholic Beverage Control impose conditions on**
9 **the issuance of the license.**

11 WHEREAS, Angry Otter, Inc., is seeking the premise-to-premise transfer of a
12 Type-48 on-sale general public premises liquor license, to do business as Tonic,
13 located at 895 Post Street (District 6); and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed twenty six (26) protests and one (1)
17 letter of support with the Department of Alcoholic Beverage Control under California
18 Business and Professions Code, Section 24013, and recommends that the Department
19 of Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the
21 following: 1) no noise shall be audible at any nearby residence; 2) petitioner(s) shall
22 actively monitor the area under their control in an effort to prevent the loitering of
23 persons on any property adjacent to the licensed premises as depicted on ABC-253;
24 and 3) the sale of alcoholic beverages for consumption off the premises is prohibited;
25 now, therefore, be it

1 RESOLVED, That in accordance with California Business and Professions Code,
2 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
3 hereby determines that the premise-to-premise transfer of a Type-48 on-sale general
4 public premises liquor license to Angry Otter, Inc., doing business as Tonic located
5 at 895 Post Street (District 6), will serve the public convenience or necessity of the City
6 and County of San Francisco; and, be it

7 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
8 San Francisco hereby endorses and adopts the recommendations of the Police
9 Department listed above and recommends that the Department of Alcoholic Beverage
10 Control issue the license with those conditions.
