12 WHEREAS, Smarte Carte met the minimum qualifications and submitted a responsible  
13 and responsive proposal; and

14 WHEREAS, The Airport Luggage Cart Lease has a term of three years, with one three-  
15 year option to extend; and

16 WHEREAS, The Airport Commission adopted Resolution No. 19-0069 on April 2, 2019,  
17 awarding the Airport Luggage Cart Lease and Operating Agreement No. 19-0069 to Smarte  
18 Carte Inc.; now, therefore be it

19 RESOLVED, That this Board of Supervisors hereby approves the Airport Luggage Cart  
20 Lease and Operating Agreement No. 19-0069, in an amount not to exceed \$6,493,853; a  
21 copy of which is on file with the Clerk of the Board of Supervisors in File No. 190705; and, be

23 FURTHER RESOLVED, That within thirty (30) days of the lease being fully-executed  
24 by all parties, the Airport Commission shall provide the final lease to the Clerk of the Board for  
25 inclusion into the official file.
